



ALUMINUM AWNINGS & PATIO COVERS

TEN YEAR LIMITED WARRANTY

Age Craft Mfg., Inc. proudly extends a ten (10) year limited warranty on our Aluminum Awnings and Patio Covers. This warranty applies only to the original residential retail purchaser in the original installed location. Age Craft Mfg., Inc. warrants against the Products containing manufacturing defects causing peeling, blistering, flaking, splitting, rusting, chipping, or cracking. The term "cracking" as used herein should not include minute fracturing of the Products which may occur during proper fabrication of the Products. The period of the warranty is ten (10) years beginning on the date the Product was invoiced to you by Age Craft Mfg. The warranty is subject to the conditions, remedies, probations, limitations, and legal rights stated in this Warranty.

Installation Service performed by Age Craft Mfg, Inc. is warranted for one (1) year from the date of installation. A service fee will be charge on service calls after the one (1) year Service Warranty period. Please note: the installed Product will still have a ten (10) year limited warranty as stated above, the Installation Service is the only part of this Warranty that will expire one (1) year after the installation is completed.

This Warranty is not transferable. The warranty does not cover fading, staining, or chalking of any painted or anodized finish. Normal weathering and aging of existing Products will preclude perfect color match of refinished or replaced Products. Age Craft Mfg. reserves the right to discontinue and make changes in any of its Products. In the event the Products referred to in this warranty are not available, Age Craft Mfg. shall have the right to substitute Products that in Age Craft's discretion are of equal grade, quality, and price. Age Craft does not warrant against and shall not be liable for any damage to the Products when due to any cause, other than manufacturing defects, including but not limited to damage caused by faulty or improper installation or application of the Products or settlement, distortion, warping, failure, or cracking of the wall or to the materials to which any of the Products are applied: earthquake, hurricane, tornado, cyclone, gale, lightning, fire, acts of God, flood, wine-borne objects, ice, hail, or weather of catastrophic nature as defined by the United States Weather Bureau, harmful chemicals, salt spray, fumes or vapors directly applied to the Products or in the atmosphere, vandalism, misuse, physical abuse, riot pr insurrection or civil disorder, negligence, or failure to provide reasonable and necessary maintenance of the Products to prevent an accumulation of surface dirt, staining, or mildew.

Age Craft Mfg., Inc. is giving you an express (10) year limited warranty under the provisions of the Magnuson-Moss Federal Warranty Act. As set forth in 15 uscs section 2301 et seq., Age Craft cannot and shall not be liable to you for breach of any other written or oral express warranties, such as those, if any, given to you by dealers, contractors, or distributors of awnings or patio covers. Any implies warranties imposed by law, such as the implied warranties of merchantability and fitness for purpose are limited in time to the duration of this express warranty. Age Craft Mfg., Inc. shall not be liable to you for any consequential damages or incidental damages for breach of any express, written, oral or implied warranty on the Products. Your exclusive remedy shall be repaired, refinished, or new Products only on the terms stated in the Warranty. Any claims do not extend the duration of the warranty.

This Warranty expressly excludes any incidental or consequential damages. Some states do not allow limitations on how long an implied warranty lasts and/or do not allow the exclusion of incidental or consequential damages, so the above limitations and exclusions may not apply to you. This Warranty gives you specific legal rights and you may also have other rights that vary from state to state.

CLAIM PROCEDURE

To make a claim under this Warranty the original consumer must do the following:

1. Write a letter explaining the problem, include the number of pieces and the size of each piece for which the claim is made. Send along with Proof of Purchase of the product, as shown on the original invoice. Note: Do not begin any repairs prior to writing Age Craft, as Age Craft must have reasonable opportunity to inspect the Products for defects before repairs are begun.

3. If your Products contain manufacturing defects. Age Craft will deliver to you, refinished, repaired, or new Products to remedy the defective Products on the following basis:
 - a. During the first (5) years of the warranty period, you will receive refinished, repaired, or new Products without charge to remedy any defective part of the warranted Products.
 - b. During the last (5) years of the warranty period, you will pay fifty percent (50%) of the then current cost to refinish, repair, or replace the defective Products
